<p>ITEM 10</p> <p>SUPPLEMENTS AND REISSUES</p> <p>When reference is made in this tariff, or supplements, to other publications for rates or other information, it includes "Supplements thereto or successive issues thereof."</p> <p>Where reference is made in this tariff to items, it includes "reissues" of such items.</p>	<p>ITEM 100</p> <p>STORAGE CHARGES FOR FAILURE TO PULL INTERCHANGE</p> <p>Connecting carriers, BN or UP, shall be billed storage charges monthly, accrued daily, for failure to pull interchange offered by fax list as follows:</p> <p>A. Pulled within 12 hours of fax time..... No Charge</p> <p>B. Pulled between 13 - 24 hours of fax time on list.....\$ 25.00 Per Car</p> <p>C. Pulled between 25 - 36 hours of fax time on list.....\$ 50.00 Per Car</p> <p>D. Pulled between 37 - 48 hours of fax time on list.....\$ 100.00 Per Car</p> <p>E. Pulled between 49 - 60 hours of fax time on list.....\$ 200.00 Per Car</p> <p>F. Pulled between 61 - 72 hours of fax time on list.....\$ 400.00 Per Car</p> <p>G. Pulled after 72 hours of fax time on list.....\$1000.00 Per Car</p>
<p>ITEM 15</p> <p>REFERENCE TO TARIFFS, ITEMS, NOTES, RULES, ETC.</p> <p>Where reference is made in this tariff to another tariff by ICC number, such reference applies also to such tariff as it may be applicable on intrastate traffic, or traffic within Canada.</p> <p>When the words tariff, tariffs or contracts are used in this tariff, they refer to tariffs or contracts lawfully on file with the Interstate Commerce Commission as to interstate traffic and State Commissions as to intrastate traffic.</p>	
<p>ITEM 20</p> <p>METHOD OF CANCELLING ITEMS</p> <p>As this tariff is supplemented, numbered items with letter suffixes cancel correspondingly numbered items in the original tariff, or in a prior supplement. Letter suffixes will be used in alphabetical sequence starting with A. Example: Item 100-A cancels Item 100 and Item 300-B cancels Item 300-A in a prior supplement which, in turn, cancelled Item 300.</p>
